INSTRUCTIONS FOR APPLICATION

1. All applications must be made in PRINT or BLOCK LETTERS on the original application form.
2. All applicants must affix a photograph on the application form and provide another 3 photographs of him/herself, his/her spouse and children who are 12 years or above but below 21 years of age. Please note that the photographs must be passport sized.
3. All applicants must submit photocopies of his/her NRICs/Passport, spouse's NRIC/Passport, Employments/Dependents Pass, Marriage and Birth Certificates. Please note that for Singapore PR, a copy of the Re-entry permit granting unlimited access must also be submitted.
4. All applications should provide two referees who are members of the Club and to whom the Club can make reference.
5. All applicants must be accompanied by the appropriate payments including a membership deposit. In event that an applicant is unable to provide any referee, he/she shall pay an additional \$500 for the above refundable membership deposit.

Membership Deposit (with referee) is as follows:-

Membership Deposit (without referee) is as follows:-

Permanent Membership: \$1,500

All cheques must be crossed and made payable to '**Jurong Country Club**'.

Cashing of cheques does not denote acceptance of application or election of membership.

Note: \$700.00 would be refunded upon attendance of the 'Meet-the-Committee-Member' session.

6. All applicants must complete the application form in full and must ensure that all information given is true and accurate.
Note: Membership may be withdrawn at any time if it is found that any information given is false or inaccurate.

TERMS AND CONDITIONS OF APPLICATION

1. Any individual who:
 - (i) is an enemy alien of Singapore;
 - (ii) has been adjudicated a bankrupt;
 - (iii) has been convicted of an offense involving violence or dishonesty or suffered imprisonment for any reason whatsoever; and
 - (iv) is facing any criminal proceedings;shall not be eligible for membership
2. Individuals whose applications are accepted for membership agree to be bound by and to abide by the Constitution, prevailing Rules and Bye Laws of the Club, as may be amended from time to time.
3. The Club reserves the right to reject any application without having to assign any reason whatsoever.
4. In the event that an applicant opts to pay the membership fee in monthly instalments, the applicant may be required to produce documentary evidence of payment ability e.g. income statements etc. The monthly instalments shall be debited to the applicant's statement of accounts for each payment and in the event that 3 or more consecutive instalments remain overdue, membership of the Club shall be immediately terminated and all membership privileges shall immediately cease.
5. In the event of termination of membership, all remaining instalments shall become immediately payable and shall be recoverable as a debt due and owing to the Club. The applicant shall also pay (on a full indemnity basis) for all costs, charges and expenses incurred in the recovery of monies due and owing to the Club.
6. Rule 26.4 of the Club's Constitution regarding the transfer of membership by a member or the Club in the event of termination of membership shall apply:

Rule 26.4

Where a Member holding a transferable membership ceases to be a Member (except in the case of death), he shall transfer his membership within 3 months of his ceasing to be a Member. Failing which, the Club shall have the right to transfer his membership at the market price on his behalf. All expenses (including transfer fee) incurred by the Club in connection with the transfer and all monies due to the Club, if any, shall be deducted from the proceeds of sale. The balance of the proceeds shall be paid to the Member or where appropriate to the Official Assignee. The Club shall not be liable for any loss resulting from the transfer of the membership.

7. Upon opting for the instalment payment scheme, the applicant shall sign an escrow transfer form which will be retained by the Club until full payment of the membership fee has been received by the Club, whereupon the signed escrow transfer form shall be returned to the applicant (member) for cancellation. The Club undertakes to safe-keep the signed escrow transfer form and not to use the signed escrow transfer form except as permitted under Rule 26.4.
